MAINTENANCE & EXTENDED SERVICE AGREEMENTS:

- Maintenance or extended service agreements (defined as multi-year extended parts and/or labor warranty) cannot be the primary and/or only purchase. This is defined as the maintenance agreement not exceeding 50% of total purchase amount.
- Maintenance agreements are permitted to be purchased within 12 months (24 months for JB & A Extended Warranties) of new product purchase date as long as warranty is 50% or less of original purchase.
- Merchant, and not Synchrony, is responsible for remitting payment owed to its vendor, the authorized Warranty provider, for any warranty transaction made on a Synchrony account under the Merchant Agreement.
- Maintenance or extended service agreements must be underwritten through Synchrony's list of approved Warranty and Service Providers.
- For a list of Synchrony approved Warranty and Service Providers please contact your Synchrony Sales Representative.
- Merchant underwritten extended Warranty and Service contracts are not allowed.

MERCHANT PROVIDED PREVENTATIVE MAINTENANCE AND CONSUMABLES:

- Merchant provided preventative maintenance (e.g., Spring Air Conditioning or Fall Furnace tune-up to ensure equipment is operating at maximum efficiency) and/or consumables (e.g., furnace and humidifier filters, UV light replacement, refrigerant) sales are permitted and may be processed as stand-alone transactions.
- Pre-funding/billing in advance of preventative maintenance service or consumables delivery is not allowed.
